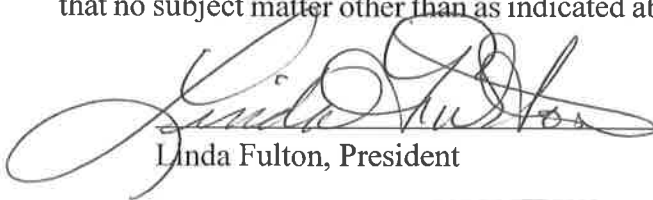
MEMORANDUM OF EXECUTIVE SESSION

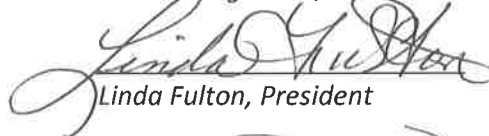

Personnel Matters – Attorney Bachman recommended that the Council make a motion to allow Council President, as current acting President, to take disciplinary action as needed including termination of an employee and giving her said authority only while she is the current acting President. This authority can be rescinded at any given time should the Council decide to do so in the future. Councilmember Barry Wilcox made the motion to authorize Council President Linda Fulton as the Town Council President, while she is the acting Town Council President, to be able to implement disciplinary policies, procedures and action per our manual including but not limited to termination at her discretion, second by Councilmember Bill Stitt, all in favor

Combining checking accounts – The Town currently has two checking accounts, one for the Town General accounts and one for utility accounts. With the implementation of the BS&A conversion to the Cloud based system, BS&A representatives said this would be best time to combine these now while they are here working on the conversion. This is something that had been contemplated and was cleared with the SBOA previously when we had thought of doing so. Clerk-Treasurer Parsons said she would like it in the minutes that we are combining the two checking accounts into one. Councilmember Scott Glendening made the motion to acknowledge and approve that the accounts have been combined, second by Councilmember Ashlee Hoos, all in favor.

Motion to adjourn at 4:49 p.m. by Councilmember Ashlee Hoos, second by Councilmember Dr. William Stitt, all in favor.

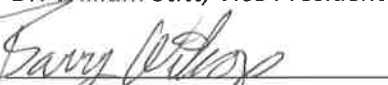
