Applicant's Basic Eligibility Requirements

Each applicant for employment will compete against other applicants in the steps of the selection procedure. Only those who possess the best mental, moral and emotional fitness for the performance of the police duties will be considered.

Listed below are the basic eligibility requirements. On a separate page you will find the physical fitness requirements and job description.

- A. Must be a United States Citizen
- B. Must be twenty-one (21) years of age when appointed as a police officer.
- C. Must possess strength and agility necessary to complete the physical conditioning and psychomotor skills, exit requirements of the Indiana Law Enforcement Academy.
- D. Must have acuity of vision correctable to 20-40 or better in each eye. Must be able to distinguish the colors red, green and amber.
- E. Must possess, as a minimum, auditory acuity that is within normal range in both ears.
- F. Must be free of any inhibiting factors, including physical or mental disability that interferes with the ability to successfully complete the basic training requirements at the Indiana Law Enforcement Academy.
- G. Must be of such physical state so as to sustain the rigors and demands of law enforcement and police service.
 - a. "Physical state" means to be in such physical condition and health to meet the minimum standards of a department Physical Ability Test.
- H. Must be of such mental state so as to sustain the rigors and demands of law enforcement and police service.
 - a. "Mental state" means having the ability to exercise good judgment; having balance temperament; being free of debilitating psychological disorders and being of such psychological health to adequately complete psychological testing.
- I. Must be a high school graduate by an accredited high school, or an equivalency diploma (GED) issued by an accredited agency.
- J. Must possess a valid driver's license from the state of residence. A copy of the driver's license must be submitted with this application.
- K. Must be a person of good reputation and excellent character. Excellent character includes having favorable references from previous employers, credit history, and personal references. Excellent character also includes an absence of pattern or practice of substance abuse.
- L. Must not have been convicted of a felony, misdemeanor domestic violence or any crime involving moral turpitude.
- M. Must have received an Honorable discharge, if ever enlisted in the United States Armed Forces.
- N. Must display emotional maturity and ability to handle stressful and volatile situations associated with police work, in a professional manner.
- O. Must be willing, if appointed to reside within a two (2) mile radius of the Town of Fremont, within the State of Indiana.
- P. Must be able to adapt to the changing weather conditions, work environment, irregular and/or extended hours, and to perform duties despite the stress of potential personal injury or loss of life. Ability to serve on 24-hour call and appropriately respond to emergencies from off-duty status as assigned or directed.
- Q. Must meet current Indiana Law Enforcement Academy physical standards and general requirements for appointment as a police officer in the State of Indiana.
- R. Must pass a complete criminal history back ground check by Steuben County Sheriff's office for access to the Spillman law enforcement reporting system.
- S. Must be able to pass pre-employment drug screening and physical examination and must also agree to take a voice stress test and undergo psychological testing.

Sequence for Hiring of Deputy Marshal

Each applicant must successfully pass each step before moving on to the next step listed.

- 1. Requirements listed
- 2. Submission of a complete application
- 3. Preliminary background investigation- driver's license, criminal history
- 4. Standard written testing
- 5. Physical testing, see requirements
- 6. Individual interview and further background study
- 7. Town Council interview
- 8. Psychological testing, polygraph/voice stress, drug screen, medical examination

Upon the successful completion of the entire hiring sequence by a candidate, the Fremont Town Marshal may recommend the most qualified applicant to the Fremont Town Council. The Council may extend a "conditional offer of employment" to the candidate. Upon acceptance of offer, a Fremont Deputy Marshal shall be on a probationary status during the first year of employment. As a condition of continued employment as a Fremont Deputy Marshal, he/she must complete the Indiana Law Enforcement Academy Officer Basic Course as prescribed by the Indiana Law Enforcement Academy.
